The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be Land Trust Foundation Inc.

ARTICLE II PLACE OF BUSINESS / ADDRESS

ARTICLE II PURPOSE

The specific purposes for which the corporation is organized are for:

It has a philosophy of operating this non-profit corporation following Christian principals dedicated to assisting homeless persons undergoing foreclosure, community service, and development organizations. It shall have all the authority permitted for not for profit organizations to engage in any or all lawful activities permitted under the laws of the United States of America, the State of Florida, or any other state, country territory or nation.

ARTICLE IV ELECTION OF DIRECTORS

The affairs of the corporation shall be managed by a Board of Directors. The Board shall have the power to admit members of the corporation in such manner, subject to such qualification, and upon such terms and with such rights as may be provided from time to time by By-Laws of the corporation.

Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations or organizations as said court shall determine, which are organized and operation exclusively for such purposes.

ARTICLE IX MEMBERS

The members of this corporation shall have no rights, title or interest whatsoever in its income, property, or assets. Nor shall any portion of such income, property, or assets be distributed to any member on the dissolution or winding up of this corporation. Members of this corporation shall not be personally liable for the debts, liabilities or obligations or the corporation and shall not be subject to any assessments.
