#### ARTICLES OF INCORPORATION FOR THE COMMUNITY PARTNERSHIP FOR THE PROTECTION OF CHILDREN JACKSONVILLE, FLORIDA, INC.

### <u>ARTICLE I</u>

OSES J. M.O. C. The Name of this corporation shall be the Community Partnership for the Protection of Children Jacksonville, Florida, Inc., hereafter referred to as CPPC.

#### ARTICLE II **Principle Place of Business and Address**

The principle office of this corporation is in Jacksonville, Florida. The mailing address of the corporation is 3701 Winton Drive, Jacksonville, FL, 32208.

This organization is organized and shall be operated exclusively for charitable purposes as may qualify it for tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, for the following purposes.

CPPC shall fundamentally change and expand traditional responses to child abuse and neglect by establishing a community-based child protection system throughout the 08/09 zip code areas of Jacksonville, Florida and influence its implementation through out the city of Jacksonville and across the state of Florida. The community-based child protection system will mean that:

- Children will be less likely to be abused or neglected.
- Children who come to the attention of the child protection system will be less likely to be reabused or re-neglected,
- The rate of serious injury to children due to abuse and neglect will decrease.

The nucleus of community-based care shall be the family and the nucleus of the CPPC process shall be the Family Team Meeting/Individualized Course of Action process, a process which seeks to empower families to discover their unique strengths, their areas of need and establish a plan to meet that need; thereby adding to their strengths.

#### ARTICLE IV **Board of Directors**

The Governing Board of the CPPC shall be composed of both elected and appointed members. The elected members shall be the presiding officers and shall consist of a chair, vice-chair, secretary and treasurer. The elected officers, along with the Program Director of the corporation shall make up the Executive Committee. Ideally, the elected officers shall be nominated from the seated Board with a term of office not to exceed two years and up to two consecutive terms. Nominations can be made by any appointed board member.

Appointed Board members will consist of agency, association, organization, business, church or school decision makers and shall be invited to sit on the Governing Board with the approval of the CPPC

Executive Committee. The Governing Board shall consist of not less that five nor more than twenty five members.

The Board of Directors shall be responsible for the development, management and control of the affairs, property and funds of the corporation and shall exercise all such powers and authority as are expressly or by implication, conferred on them by these Articles of Incorporation, the by-laws of the corporation and the State of Florida.
