The undersigned subscriber to these Articles of Incorporation a natural person competent to contract, hereby form a not for a profit corporation under the law of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be: Coqui Dancers, Inc.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State, unless dissolved according to Florida Law.

**ARTICLE III -DISPOSITION OF ASSETS ON DISSOLUTION**

If this corporation has to be dissolved for any reason, all its assets shall be transferred to one of the affiliated not for profit organizations located within the Osceola County, City of Kissimmee, Florida.

**ARTICLE IV - PURPOSE**
