ARTICLE I. - NAME

The name of this corporation is GRACE BIBLE CHURCH OF PINELLAS, INC..

ARTICLE II. - ENABLING LAW

This corporation is organized pursuant to the Corporations Not For Profit law of the State of Florida, set forth in Part One of Chapter 617 of the Florida Statutes.

ARTICLE III - PURPOSES

- A. The specific and primary purpose for which this corporation is organized is Church...
- B. The general purposes for which this nonprofit corporation is formed are: religious worship, education and outreach.
 - C. This corporation is organized and operated exclusively for operating a church.
- D. This corporation shall have and exercise all rights and powers conferred upon corporations enumerated under the Florida General Corporation Act of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes as set forth in subparagraphs "A" through "C" of this article.

ARTICLE IV - TERM

This corporation shall have a perpetual existence.

ARTICLE V - INCORPORATOR(S)

ARTICLE VI - MEMBERSHIP

The membership of this corporation shall be limited as follows: to those persons interested in a non-denominational church.

ARTICLE VII - MANAGED OF CORPORATE AFFAIRS

A. <u>Board of Directors</u>. The powers of this corporation shall be exercised, its properties controlled and its affairs conducted by a Board of Directors. The number of directors herein provided for may be changed by a bylaw duly adopted by the members entitled to vote. Directors shall be elected/appointed annually by majority vote of the memberships.

B. <u>Elective Officers</u>. The officers of this corporation shall be a president. Other offices and officers may be established or appointed by members of this corporation at any regular annual meeting. The qualifications, the time and manner of electing or appoint, the duties of, the terms of office, and the manner of removing officers shall be as set forth in the bylaws.

The officers who are to serve until the first election of officers under the Articles of Incorporation are:

C. <u>Standing Committees</u>. This corporation shall have at least two standing committees: The Board of Directors shall elect annually, from its members, an executive committee of three persons and an admission committee of three persons. ARTICLE X - BYLAWS

ARTICLE XII - DISSOLUTION

This corporation shall be dissolved and its affairs would up by a two-thirds vote of the corporations's voting members or when the objects for which the corporation is organized has been fully accomplished.
