**ARTICLE I**

THE NAME OF THE CORPORATION SHALL BE UTM OUTREACH, INC.

**ARTICLE II**

THE PRINCIPAL OFFICE OF BUSINESS AND MAILING ADDRESS OF THIS CORPORATION SHALL BE:

**ARTICLE III**

THE PURPOSE FOR WHICH THIS CORPORATION IS ORGANIZED IS TO ACT AS A SOCIAL SERVICE ORGANIZATION TO ASSIST INDIVIDUALS AND OTHER INSTITUTIONS CONNECTED THEREWITH OF A RELIGIOUS, EDUCATIONAL, CHARITABLE AND BENEVOLENT NATURE, AND TO ENGAGE IN CHARITABLE, HUMANITARIAN AND PHILANTHROPIC ACTIVITIES TO THE BENEFIT OF THE UNDER PRIVILEGED MEMBERS OF SOCIETY, CREATING PROGRAMS FOR CHILDREN AND THE DISADVANTAGED.

THE CORPORATION IS ORGANIZED AND OPERATED EXCLUSIVELY FOR CHARITABLE AND EDUCATIONAL PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY OUT ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (1) BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986, (OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW), OR (ii) BY A CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER 170 (C)(2) OF THE INTERNAL REVENUE CODE OF 1985 (OR CORRESPONDING OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW).

**ARTICLE IV**

THE MANNER IN WHICH THE DIRECTORS ARE ELECTED AND/OR APPOINTED IS THUS: THE BOARD OF DIRECTORS WILL CONSIST OF SEVEN DIRECTORS, THERE WILL BE FIVE APPOINTED DIRECTORS AND TWO ELECTED DIRECTORS. ADDITIONAL DIRECTORS MAY BE APPOINTED BY THE STATE OF FLORIDA SO THAT SAID CORPORATION MIGHT QUALIFY FOR ASSISTANCE FROM FLORIDA COMMUNITY DEVELOPMENT CORPORATION SUPPORT AND ASSISTANCE PROGRAMS AND THE LIKE.




