ARTICLES OF INCORPORATION OF WALK BY FAITH MINISTRIES, INCORPORATION

OR SER 12 MINO. 26 The undersigned associate together for the purpose of becoming a church corporation not for profit under Chapter 617, Laws of the State of Florida, providing for the information, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE 1: NAME

The name of this not for profit church corporation shall be Walk by Faith Ministries Inc.

ARTICLE 11: PURPOSE

This not for profit church corporation is organized exclusively for religious, charitable, scientific, literary and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 or the successor provision of any future United States Internal Revenue Law.
