ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

ST. PETERSBURG CHAPTER OF SAMARITAN CORPORATION, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

TO PROVIDE A CHARITABLE NON-PROFIT ORGANIZATION TO THE COMMUNITY. THIS ORGANIZATION WILL PROVIDE RESIDENTIAL TREATMENT PROGRAMS FOR TRANSITIONAL HOUSING, TO EDUCATE AND REHABILITATE BOTH MALE AND FEMALE OFFENERS IN PINELLAS AND SURROUNDING COUNTIES. TO IMPLEMENT YOUTH PREVENTION AND INTERVENTION PROGRAMS TO TARGET AT RISK YOUTH IN THE COMMUNITY AND HELP IMPROVE ECONOMIC CONDITIONS TO LOW INCOME HOUSING. THE PROGRAM WILL DEVELOP A FAITH BASED INITIATIVE THAT WILL ENCOMPASS VOLUNTEERISM AND FAMILY CENTERED ACTIVITIES FOR COMMUNITY SERVICES.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

VOTED UPON BY THE BOARD OF DIRECTORS. THE PROPERTY, BUSINESS AND AFFAIRS SHALL BE CONTROLLED AND MANAGED BY A BOARD OF DIRECTORS. MANAGEMENT OF THE CORPORATION MAY EXERCISE POWER OF THE CORPORATION AND DO ALL LAWFUL ACTS AND ACTIVITIES/THINGS THAT ARE NOT STATUE OR BY CERTIFICATE. THE ORGANIZATION MUST HAVE A MAJORITY OF ITS GOVERNING BODY OR MEMBERS PRESENT TO CONDUCTS BUSINESS.
