Pursuant to the provisions of 617.1001, 617.1002, and 617.1006 of the Florida Statutes, St. Anthony's Primary Care, Inc., a Florida not for profit corporation, adopts the following Articles of Amendment (this "Amendment") to its Articles of Incorporation:

- Name of Corporation. The name of the Corporation is St. Anthony's Hospital, Inc. (the "Corporation").
- 2. Text of Amendment. Articles III, IV, and VI are hereby deleted in their entirety and the following articles are substituted in their stead:

ARTICLE III

This Corporation is organized as and shall be operated as a not for profit corporation. The Corporation may engage in any business which is permissible under the Florida Not For Profit Corporation Act.

ARTICLE IV

The Corporation shall have a sole member. The sole member of the Corporation shall be St. Anthony's Hospital, Inc., a Florida not for profit corporation.

ARTICLE VI

The sole member shall have the power to appoint and remove the Corporation's Directors, to approve all amendments to the Corporation's Articles of Incorporation and to amend and rescind the Corporation's Bylaws.
