## Articles of Incorporation

The undersigned, acting as incorporators of corporation pursuant to chapter 617, Florida Status, adopt the following Articles of incorporation.

### Article I Name

The name of the corporation shall be: Iglesia Cristiana El Poder De La Palabra, Inc.

### Article II The principal Place of Business and Mailing Address

The principal place of business and mailing address of this corporation shall be:  
5212 Sunset Trail; Lake Worth, FL 33463

### Article III Purpose

The specific purposes for which the corporation is organized are to establish a congregation of believers in Jesus Christ among the Hispanic community of Lake Worth, West Palm Beach, FL and to proclaim the gospel message of Christ throughout the world. The corporation will establish and maintain other religious ministries for the sake of the congregation and the community as these needs become evident to the directors of the corporation.

The purposes for which the corporation is organized are exclusively religious, charitable, literary and education within the meaning of section 501 © (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 © (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon dissolution of the organization, assets shall be distributed for on or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law, or shall be distributed to the federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.

### Board of Directors

The directors of the corporation shall consist of the pastors / elders of the congregation. The same shall be elected by the congregation as prescribed in the bylaws of Iglesia Cristiana El Poder De La Palabra.

The affairs of the Corporation shall be managed by a board of Directors consisting of no less than three directors. 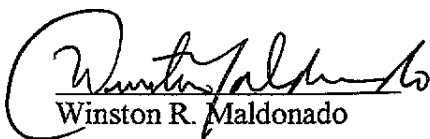

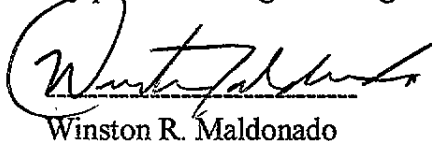
