ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of this corporation shall be:

THE HOUSE OF POWER & PRAISE MINISTRY, INC.

ARTICLE II. ADDRESS

The initial street address of the principal office of the corporation in the State of Florida shall be at: 1029 Santa Anita, Orlando, Florida 32808. The Board of Directors may from time to time move the principal office to any other place or places as may be designated by the Board of Directors.

ARTICLE III. EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV. PURPOSES

The purpose of this corporation shall be to operate exclusively for religious, charitable, scientific, literary and educational purposes and in furtherance of such goals, is authorized to do any or all activities which it is empowered to do under Chapter 617 F.S. as appropriate; provided, however, that nothing herein shall be construed as allowing any activities which would jeopardize the corporation's tax-exempt status or otherwise be inconsistent with its classification as an organization described in section 501© (3) of the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue Code.

The corporation shall conduct among other religious activities the following operations:

To conduct church services, conferences, seminars, workshops, meetings and conventions.

To promote, sing, preach, proclaim, publish, distribute and disseminate the Gospel of our Lord Jesus Christ and His Kingdom and all truths based upon and contained within the Word of God, the Holy Bible.

ARTICLE VIII. PROHIBITED ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted by to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which deductible under Section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future tax code.

ARTICLE IX. DISTRIBUTION UPON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 © (3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or shall be distributed to federal government, or to a state or local government, for exclusive public purposes. Any such not so disposed shall be disposed by a court of competent jurisdiction in the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE X. BY-LAWS

All by-laws shall be made, altered or rescinded by the vote of two-thirds of the active membership of the corporation present at any regular meeting of the corporation or at any special meeting duly called for the purpose.

To educate, teach, counsel and instruct all people about the doctrines, teachings, and information contained in the Holy Bible.

ARTICLE V. I INCORPORATOR

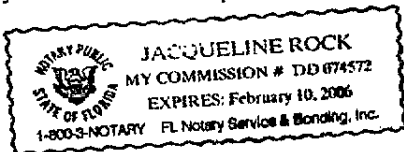
