## **ARTICLES OF INCORPORATION**

Articles of Incorporation of Central Christian Academy, Inc. The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation in compliance with Chapter 617, F.S., (Not for Profit), do hereby certify:

### **ARTICLE I**

#### ***Name***

The name of the Corporation shall be Central Christian Academy, Inc.

### **ARTICLE II**

#### ***Principal Office***

The principal office and mailing address of this Corporation shall be 1225 West 25th Street, Orlando, FL 32805

### **ARTICLE III**

#### ***Purpose(s)***

- A. This corporation shall be organized and operated exclusively for educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- B. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

### **ARTICLE IV**

#### ***Manner of election of officers***

The manner in which the officers are elected shall be stated in the bylaws.




