**Articles of Incorporation
of
The Jobs Partnership of Palm Beach County, Inc.**

In compliance with Chapter 617, F.S., (Not for Profit)

1. The name of the corporation shall be The Jobs Partnership of Palm Beach County, Inc.
2. The principal place of business and the mailing address of this corporation shall be 1233 45th Street, Suite C4, Mangonia Park, Palm Beach County, Florida, 33407.
3. The corporation is organized and shall be operated exclusively for religious, charitable, scientific, literary and educational purposes, including, but not limited to , the making of donations or gifts to organizations that qualify as exempt under the provisions of section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law). More specifically, the corporation shall be operated primarily for the charitable and educational purposes of providing job training and related educational services to low-income individuals residing in Palm Beach County, Florida.

In furtherance of its purposes, the corporation shall have the power to receive contributions and allocate funds, within the discretion of its Board of Directors, (a) to any governmental unit described in section 170 (c)(1) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law) (b) to any other organization organized and operated exclusively for charitable, scientific, literary and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law), or (c) in any other manner consistent with the corporation's stated purposes and the provision of section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law). The foregoing clauses shall be construed as both objects and powers, and such enumeration of specific powers shall not be deemed to limit or restrict in any manner the general powers of the corporation and the enjoyment and exercise thereof as conferred by the laws of the State of Florida now or hereafter in effect.

The corporation shall have no power to declare dividends, and no part of its earnings shall inure to the benefit of any director or officer of the corporation or to any other private shareholder or individual. The corporation shall have no power or authority to engage in activities which consist of carrying on propaganda or otherwise attempting to influence legislation nor to participate in, or intervene in, any political campaign on behalf of any candidate for public office.

The corporation shall have no members.

4. The manner of election shall be by the vote of the Board of Directors.

8. Except to the extent that Florida law prohibits such limitation or elimination of liability of directors for breaches of duty, no director of the corporation shall have any personal liability arising out of an action whether by or in the right of the corporation or otherwise for monetary damages for breach of any duty as a director. No amendment to or repeal of this article (8) shall apply to or have any effect on the liability or alleged liability of any director of the corporation for or with respect to any acts or omissions of such director occurring prior to such amendment or repeal. of this article (8) shall not be deemed to limit or preclude indemnification of a director by the corporation for any liability that has not been eliminated by the provisions of this article.

9. In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations (having purposes similar to those described herein) which themselves are exempt as organizations described in section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law).
10. The corporation shall have the right to amend, alter, change, or repeal any provision contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute; provided, however, that under no circumstances shall these Articles of Incorporation be amended so that the corporation may operate for other than charitable, scientific, literary or educational purposes or so that any director or other private individual may participate in the distribution of the earnings, funds, or properties of this corporation. Notwithstanding any other provision of these Articles, this corporation shall not carry on any activities not permitted to be carried on by (a) a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law) or (b) a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue law).

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
