We, the undersigned, acting as incorporators of this Not For Profit Corporation adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of this Not For Profit Corporation is: The North Rosemary Christian Fellowship, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III. PURPOSE

The purpose of this Corporation is to unite Christians as a local Church for the propagation and dissemination of the Gospel of Jesus Christ, through the preaching, teaching, and living of the gospel message as outlined in the Articles of Faith of North Rosemary Christian Fellowship, Inc.

To accomplish such purpose the Corporation shall conduct regular worship services and may, among other means, establish Christian Schools and Colleges, Home and Foreign Mission Outreaches, ultimately be engaged in all types of religious and charitable activities including evangelism through electronic broadcasting, A.M. & F.M. radio, telecasting, cable and satellite television, and other related projects of the carrying out of these ministries.

ARTICLE VIII. MEMBERSHIP

Membership in this corporation is granted upon application to those who subscribe to and adhere to the doctrine as outlined in the Articles of Faith of The North Rosemary Christian Fellowship, Inc.

ARTICLE IX. MANAGEMENT OF AFFAIRS

The management of the affairs of this corporation is vested in the Pastor (Chairman of the Board) and the Board of Directors. The Corporation shall be governed by the provision contained in its constitution and bylaws.

ARTICLE X. MEETINGS

The annual meetings and special meetings of this corporation shall be held at such times as stated in the constitution and bylaws.

ARTICLE XI. PROPERTY

Section I. Documents relating to the conveying or encumbering of real estate shall be signed by the Pastor (Chairman of the Board) and one other Board Member (Treasurer).

Section II. All property of this corporation shall be recorded in the name of the church. In the event of a defection of any members of this corporation from its Articles of Faith, or from affiliation with The North Rosemary Christian Fellowship, Inc. the title of all corporation property, real or personal shall remain with those members abiding by such Articles of Faith and retaining affiliation with The North Rosemary Christian Fellowship, Inc.

ARTICLE XII. DISOLUTION

In the event of dissolution of this Not For Profit Corporation, all its property shall pass to an organization as determined by the Board of Directors of this corporation whose purpose is in harmony with the gospel message as outlined in this corporation's Articles of Faith. Such organization must be organized and operated exclusively for the purpose specified in section 501 © (3) of the Internal Revenue Code.

ARTICLE XIII. AMENDMENTS

These articles may be amended by a simple majority vote of the Board of Directors present at a duly called meeting where all Board members are notified, in written form, a minimum of ten days prior to the meeting.

Prior to amendments becoming effective, they must be ratified by a simple majority vote of all members of the congregation present and voting at an annual business meeting or a special meeting called for that purpose, where all members are notified in written form a minimum of ten days prior to the meetings. The Pastor must be present at both meetings.
