The undersigned, acting as incorporator of a corporation under the Florida Statues, adopts the following Articles of Incorporation:

Article I

The name of this principal corporation is PILLOW TALK MINISTRIES, INC.200 Third Street, Perry, Fla. 32348

Article II Purpose (s)

This Corporation is a non-profit public benefit Corporation and is not organized for the principle gain of any person. It is organized under the non- profit Public Benefit Corporation Law for Charitable and Educational purposes. We will assist the disadvantaged women, men, and children, that have been stunted by their past through oppositions, barriers, etc. We will teach them how to become self-sufficient and stronger in the one who we believe is All sufficient and that is Jesus Christ. We will provide these services by conducting classes, seminars, possible conferences, counseling, and etc. We will provide Child Care service for individuals that are in need of these kind of services. Our goal is to meet the total needs of the humanity, not only Spiritually and Mentally, but physically as well.

Article III

The address of the registered agent of the corporation is 200 Third Street, Perry, Fla. 32348. The name of the registered agent is Kathy L. Woodfaulk of PILLOW TALK MINISTRIES, INC.

Article IV

The period of duration is perpetual. The corporation is organized pursuant to the Not for Profit Corporation laws of the State of Florida. There should be no stock and will have no members.

Article V

This Corporation is organized and operated exclusively for Religious, Charitable and Education purposes with the meaning of section 501©(3) of the Internal Revenue Service Code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code or by corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code.

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
