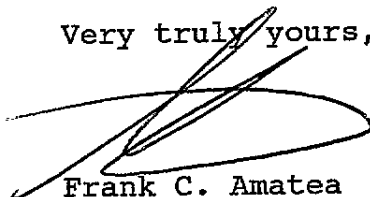

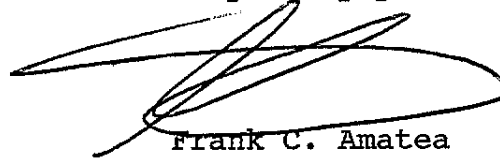

administrative act on September 24, 1999.

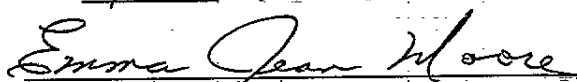
3. That neither HANG TIME SPORTS, INC., nor 1-3-2, INC., intend on applying

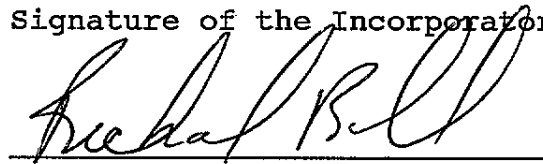

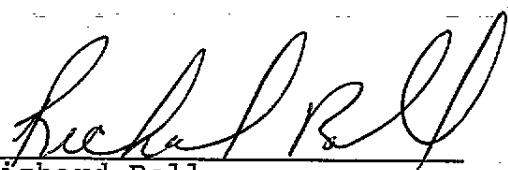
