ARTICLES OF INCORPORATION  
OF  
FLORIDA STRUCTURAL ENGINEERS ASSOCIATION - SOUTHWEST CHAPTER, INC.  
(A Corporation Not for Profit)

The undersigned, acting as incorporator of a corporation under the Not for Profit Corporation Act of the State of Florida, adopt the following articles of incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation, hereinafter referred to as the "Corporation" is FLORIDA STRUCTURAL ENGINEERS ASSOCIATION - SOUTHWEST CHAPTER, INC.

ARTICLE II - PRINCIPLE OFFICE

The principle place of business and mailing address of the Corporation shall be 5389 Marina Drive, Bokeelia, Florida 33922-3027.

ARTICLE III - PURPOSE

The Corporation is organized exclusively for charitable, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV - MANNER OF ELECTIONS

The board of directors shall consist of at least three (3) members, who need not be residents of the state of Florida.

Directors shall be elected as prescribed by the By-Laws of the Corporation.

ARTICLE V - REGISTERED AGENT
