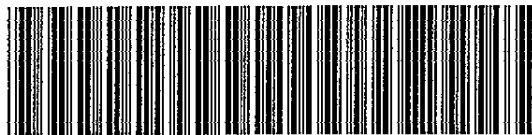



ARTICLES OF AMENDMENT, dated January 13, 2003, TO ARTICLES OF INCORPORATION OF PIPELINE INTERNATIONAL PROJECT, INC.

ARTICLE III PURPOSES(S)

The specific purpose(s) for which the Corporation is organized are amended to read:

The purposes for which Pipeline International Project, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501c(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501c(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501c(3) and 170c(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.
