This resolution has been adopted by the Board of Directors of Pipeline International Project, Inc., this 15th day of April 2003.

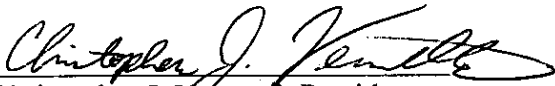
