ARTICLES OF INCORPORATION OF

LAKELAND EXECUTIVE HANGARS ASSOCIATION, INC. A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned incorporator by these articles associates himself for the purpose of forming a corporation not for profit under the laws of the state of Florida, and adopts the following Articles of Incorporation:

ARTICLE I. NAME AND ADDRESS

The name of this corporation is LAKELAND EXECUTIVE HANGARS ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association," these Articles of Incorporation as the "Articles," the Declaration of Lakeland Executive Hangars as the "Declaration," and the Bylaws of the Association as the "Bylaws."

The street address of the initial principal office of the Association is 3905 Aero Place, Lakeland, Florida, 33811-12.

ARTICLE II. TERM OF EXISTENCE

The Association shall have perpetual existence. The corporate existence will commence on the filing of these Articles with the Department of State.

ARTICLE III. PURPOSE

The purpose of this corporation is for any one or more lawful purposes not for pecuniary \overline{p} rofit.

ARTICLE IV. MEMBERS

The qualification of members and the manner of their admission to the Association shall be as regulated by the Declaration and the Bylaws.

ARTICLE V. INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VI. INITIAL BOARD OF DIRECTORS

Upon the filing of these Articles, three (3) Members of the

Association shall be named to the initial Board of Directors of the corporation. The initial Board of Directors shall serve as same until the next annual meeting. The initial Board of Directors shall, as soon as practicable after taking office, elect a President, Secretary, and Treasurer of the corporation from the Association Members named to the initial Board of Directors. 
