ARTICLE I - NAME

The name of the corporation shall be: **Divine Destiny Community Ensemble, Inc.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
3030 Juniper Drive, Edgewater, Florida 32141-6208

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is: To operate a musical ministry to provide music to churches and community organizations and the public in general. The ministry will also recruit and train people, especially young people, to become performers, singers and musicians so as to provide these persons with the opportunity to receive the benefit of the ministry and the benefit that arises from providing the ministry to others. The corporation will recruit musical groups to uplift, entertain, inform and bring a message of peace and moral self improvement to assist any who might hear the music to make better lives and better citizens. The musical groups will help members of the community make better choices, and avoid drugs, despair and crime.

ARTICLE IV - MANNER OF ELECTION

The manner in which the directors are elected or appointed: The initial incorporators of the corporation shall be permanent trustees of the corporation. They shall elect the first board of directors of the corporation. The board of directors shall elect its own members to serve at the pleasure of the board, for terms the board shall designate from time to time.

If the number of directors shall ever fall below three, the permanent trustees shall appoint the number of directors required to fill the vacancies to the number of three directors.

If the number of permanent trustees shall fall below three, the board of directors shall appoint new trustees at least to the number of three.

If both the directors and trustees shall fall below the number of three, then the remaining members of both the trustees and directors shall appoint the number of directors to at least bring their number to three trustees and three directors respectively.

In the absence of these persons, new trustees will appointed by the Mt. Olive Primitive Baptist Church of New Smyrna beach, Florida.






