

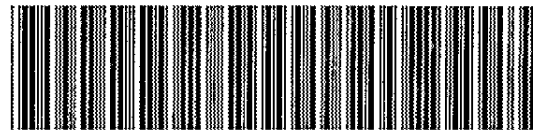




Article 8
