

ARTICLES OF INCORPORATION
OF
DEEP WATER CANALS ASSOCIATION OF NORTH SHORE,
INC.

ARTICLE I

The name of this corporation shall be DEEP WATER CANALS ASSOCIATION OF NORTH SHORE, INC. It shall be a non-profit corporation organized under the laws of the State of Florida.

ARTICLE II

The primary purpose of this corporation shall be to represent the common interest of the residents of Driftwood Drive, Coquina Drive, and Beachcomber Drive, North Shore Subdivision, Bay County, Florida and their immediate neighbors. This corporation may exercise any and all powers permitted to be exercised by non-profit corporations.

ARTICLE III

The street address of the corporation's initial registered office is 719 Beachcomber Drive, Lynn Haven, Florida 32444. The street address of the corporation's principal office is 719 Beachcomber Drive, Lynn Haven, FL 32444.

ARTICLE IV

The management of the corporate affairs of this corporation shall be managed by the Board of Directors. The method of election of the Board of Directors shall be stated in the By-laws of this corporation.
