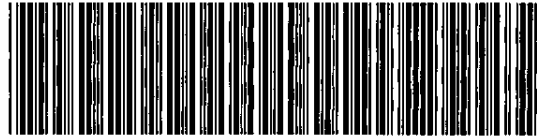

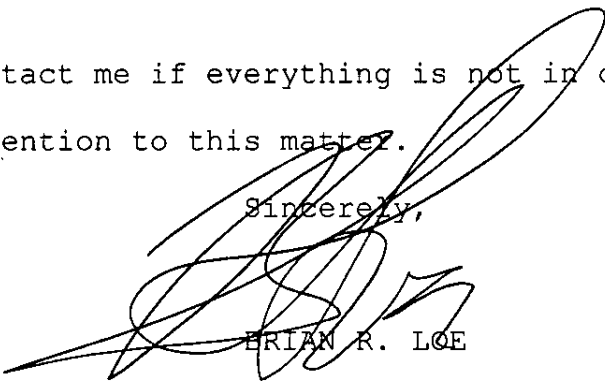

In compliance with the requirements of Florida Statutes, Chapter 617.1001, the undersigned being the only officers and directors of BE A TRAILBLAZER, INC., do hereby amend the original Articles of Incorporation:

1. ARTICLE III is amended to read as follows:

ARTICLE III

The purpose for which the corporation is organized is to enhance, landscape, blaze, and renovate the roads, trails, sidewalks, paths, parks and public thoroughfares in the City of Lake Mary, Florida, and to promote physical fitness among the population of Lake Mary, Florida and the rehabilitation and improvement of Government properties and other publicly owned facilities located within the City of Lake Mary, Florida.

2. Pursuant to Section 617.1003, Florida Statutes, the foregoing amendment was proposed to the officers, directors and record members at a joint meeting and unanimously approved.

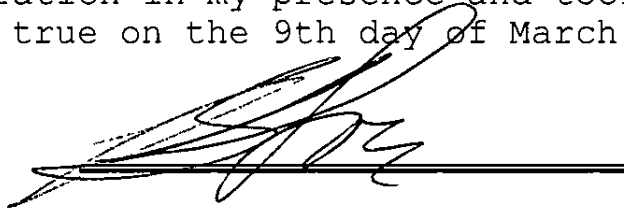
