


1. ARTICLE III is amended to read as follows:


**ARTICLE III**

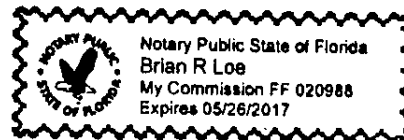
