ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I – NAME

The name of the corporation shall be: **Karma Ministries, Inc.**

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

1074 Ceasar Court, Mt. Dora Florida, 32757.

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is:

Exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and purposes pursuant to Florida Statutes, Chapter 617 – Corporations Not For Profit law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by a organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such

assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The specific purpose for which this corporation is organized is to provide spiritual, social, educational development and direction to members of the community. To accomplish this purpose, Karma Ministries, Inc. will: (a) provide forums that serve to develop spiritual leadership development and understanding among youth and adults, and (b) employ educational strategies through the study of the testimony, teachings and prophesy of Jesus Christ, and Christian Theology that will aid in the attainment of organizational goals.

ARTICLE IV – MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The directors of Karma Ministries, Inc. are appointed annually by consensus of the Board of Directors.
