The undersigned, acting as incorporator of a corporation, adopts the following articles of incorporation for such corporation:

Article I

The name of the corporation shall be HEYLO HOME, INC., and the initial principal address of the corporation is:

Article II

The period of duration of this corporation shall be perpetual, unless dissolved according to law. Corporate existence shall commence upon the issuance of the Certificate of Incorporation by the Office of the Secretary of State.
