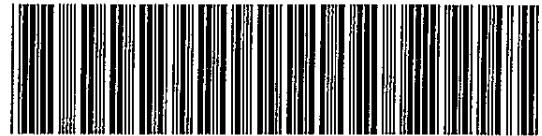

**Articles of Amendment
To
ARTICLES OF INCORPORATION
Of

The Articles of Incorporation of Wind & Rain Foundation, Inc., a Florida not for profit corporation (the "Corporation") are hereby amended pursuant to provision 617.1006 of the Florida Statutes, as follows:

First, ARTICLE I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following:

ARTICLE I – Name

The name of the Corporation shall be Ardent Housing Foundation, Inc.

Second, ARTICLE II of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the following:

**ARTICLE II
Principle Place of Business and Mailing Address**

The principal place of business and the mailing address of the Corporation shall be:

Ardent Housing Foundation, Inc.
7524 S.W. 58th Avenue
South Miami, Florida 33143

Third, ARTICLE III of the Articles of Incorporation of the Corporation is hereby modified to include the following:

- "I. to own, develop, upgrade and manage housing that is affordable to low and moderate income people."

This Amendment was approved by the Board of Directors on January 23, 2003. There are no members or members entitled to vote on the amendment.
