ONE:

The name of the corporation is F & D MINISTRIES, INC. The principal place of business and mailing address of the corporation is 1101 E. Tunis Drive, Pensacola, Florida 32503. The corporation is organized pursuant to the Florida, Nonprofit Corporation Code.

OF

TWO:

This religious corporation is a person authorized to transact business, no one may have it's name or same name, it can sue, borrow, file bankruptcy and more. This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under GOD in which we trust. In accordance to the 1st Amendment of the United States Constitution and GOD Divine Status (1 Corinthians 12:28). This Religious Benefit Corporation is part of the Church, which is the body of our Lord and Savior Jesus Christ to promote religious activities. This corporation is taxexempt and can receive tax-deductible contribution as outline in IRS Publication 557 and Application 1023. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
