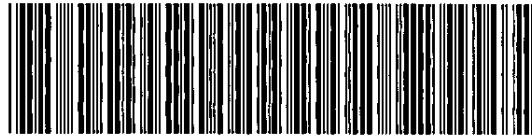



**AMENDMENTS TO ARTICLE OF INCORPORATION FOR LLOYD ACRES  
HOMEOWNERS ASSOCIATION INC. AS PER GENERAL MEETING DATED 7-14-07.**

**Amend ARTICLE 4 to include the following subsection:**

a): If at anytime the Association is unable to meet the financial obligations of Property Taxes, Corporate Dues, and Liability Insurance, the current Board, by unanimous vote, holds the following as options to dispose of the assets of the association. The assets can be dedicated to a public agency to be used for purposes similar to those for which the association was created. In the event such a dedication is refused acceptance, such assets can be granted, conveyed and assigned to any non-profit corporation, association, trust or other organization to be devoted to such similar purposes.

**Amend Article 7 by adding the following sentence to the beginning of the second paragraph:**

Lloyd Acres Homeowners Association Inc shall indemnify the Board of Directors to the fullest extent permitted by law.
