

Articles Of Incorporation Of Regency International Services, Inc.

THE UNDERSIGNED natural person being the age of eighteen (18) years or more, acting as incorporator of a corporation under the Florida Nonprofit Corporation Act, adopts the following Articles of Incorporations for such corporation:

ARTICLE I CORPORATE NAME

1. The name of the corporation is Regency International Services, Inc.

ARTICLE II DURATION

2. The period of duration of this corporation is perpetual.

ARTICLE III PURPOSES

3. The corporation is organized exclusively for charitable and educational purposes, and not for profit, including:
 1. Provide halfway housing
 2. Referral Service
 3. Emergency shelter and personal maintenance
 4. Employment Referrals
 5. Dealing with your criminal record
 6. Job applications and resumes
 7. Ongoing support

ARTICLE IV MEMBERSHIP

4. The corporation shall have no members.

ARTICLE VI BY-LAWS

5. Provisions for the regulations of the internal affairs of the corporation are to be determined and set forth in the By- Laws. The Board of Directors of the corporation shall adopt the original By Laws. Thereafter, By- Laws may be adopted, amended or repealed by the Board of Directors in accordance with the By- Laws.

ARTICLE VII

DISSOLUTION

6. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, dispose of all assets of the corporation in such manner to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501© (3)

Any such assets not so disposed of by the Board of Directors shall be disposed of by the district court of the county in which the principal office of the corporation is then located, exclusively for such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.

ARTICLE VIII

7. The number of Directors of this corporation shall be three, or more than three, as fixed from time to time by the By- Laws of the corporation. The number of Directors constituting the initial Board of Directors is three, and the names and addresses of the persons who are to serve as Directors until their successors are elected and shall qualify are:
