Termination as officer and director of Bhuvaneshwar Mandir, Inc.

Dear Mr. Rewah:

As you know, this law firm represents Bhuvaneshwar Mandir, Inc. This morning, at 10:00 a.m., the Executive Committee met at my offices pursuant to a duly called meeting by the organization's President, Prakash Gossai. You were provided Notice of this meeting on March 25, 2005 at 11:19 a.m. The meeting was attended by Seeyu Baldeo, Roopram Baijnauth, Prakash Gossai, and Bidyawattie Baijnauth, and thus a quorum was present. You failed to appear at the meeting and have failed to respond to our letter.

After a lengthy discussion, the members of the Executive Committee felt that your actions left the Committee with no alternative but to terminate your position as director and to suspend you as a priest and a representative of the organization until further notice.

There were several reasons for the Committee's decision.

- 1. The unauthorized removal of the organization's funds from the Bank and the refusal to turn over the organization's financial and corporate records.
- 2. Making numerous decisions, including a decision to hold a service in the organization's building next Sunday, without consultation, input or agreement from the Executive Committee or the President of the organization. The decision to hold service on this Sunday is especially egregious since the calendar is not right for holding these services in the new building.

3. You have embarked on a campaign to undermine the authority of the Executive Committee with the members and have ignored the duties and obligations as a Director. The organization's By-Laws clearly require decisions to be made by the Committee and they prohibit any one member from asserting unilateral control over the organization, which you have attempted to do.

Thus, it was determined by the Executive Committee that you had engaged in activities hostile to the aims of The Mandir and in conduct unbecoming of your position.

This letter is to inform you that any and all authority that you have to represent Bhuvaneshwar Mandir is hereby terminated. You are not authorized to enter onto any property owed by the organization, including the recently completed temple, until such time as you have met with the Executive Committee and these issues have been resolved. You are not authorized to conduct any business, religious or otherwise, in the name of Bhuvaneshwar Mandir. If you attempt to enter onto the property of Bhuvaneshwar Mandir, you will be considered a trespasser.

You are again instructed to turn over all financial and business records in your possession relating to the Bhuvaneshwar Mandir to Roopram Baijnauth.

If we do not receive a response to this letter from you by Friday, April 1, 2005 at 10:30 a.m. confirming that you will not attempt to hold services on Sunday, April 3, 2005, then you will leave the Executive Committee no alternative but to take all legal action necessary to protect its property and to ensure that you do not trespass on the property of Bhuvaneshwar Mandir or otherwise violate the Committee's instructions to you.

PLEASE GOVERN YOURSELF ACCORDINGLY.
