**ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **gr8view incorporated**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: Non-profit organization to establish and maintain an outreach program to provide eyecare and eyewear to underprivileged residents of the State of Florida and potentially outside the United States. Business plan includes the creation and maintenance of a self-contained mobile eyecare unit designed to act as a traveling eye clinic and optical dispensary, as well as a portable system/program for travel outside the United States, coordinating care with local religious mission organizations.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
