**ARTICLES OF INCORPORATION
OF
Lauderdale Lakes Track Club Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Lauderdale Lakes Track Club Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: Track team.
