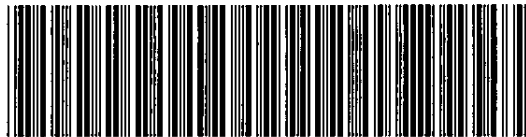

Please note that I am resending both the **Application for Reinstatement with check#2177 in the amount of \$306.25** and the **Articles of Amendment with check# 3621 in the amount of \$43.75** which will replace check#3601 which has not been either returned or processed to date. I am also enclosing a copy of the two checks that were originally sent together on May 11<sup>th</sup>, 2007.
