**ARTICLES OF INCORPORATION  
OF  
COMMON GROUND CHURCH, INC.  
A NOT FOR PROFIT CORPORATION**

**ARTICLE I - NAME**

The name of the corporation shall be:

**Common Ground Church, Inc.**

**ARTICLE II – PRINCIPAL OFFICE**

The street address of the initial principal office of the corporation shall be Common Ground Church, 2630 NW 39<sup>th</sup> Avenue, Gainesville, FL 32605 and the mailing address of the corporation shall be Common Ground Church, 2630 NW 39<sup>th</sup> Avenue, Gainesville, FL 32605.

**ARTICLE III – PURPOSE AND DURATION**

The general purpose for which this corporation is organized shall be as a not-for-profit religious organization which shall conduct any and all lawful business which a not-for-profit religious organization may conduct, however the primary purpose of the corporation shall be a Christian Church of the Lord Jesus Christ dedicated to sharing the Gospel with others. The duration of the corporation shall be perpetual.
