We, the undersigned incorporators, hereby associate ourselves and make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purpose of forming a Corporation Not For Profit pursuant to Chapter 617, Florida Statutes.

**ARTICLE I
NAME**

The name of this corporation shall be:

FLORIDA HISPANIC AMERICAN VOTERS LEAGUE Inc.

**ARTICLE II
PRINCIPLE OFFICES**

The principal office of the corporation will be in the City of Winter Springs, State of Florida.

Winter Springs, Florida 32708

**ARTICLE III
PURPOSE**

A) This corporation is organized and shall be operated exclusively as a not-for-profit organization which uses the goals and methods of social work, economics, and other disciplines to secure the political advancement of the Hispanic-American citizens in the United States and particularly the State of Florida.

B) Its purpose is to provide non-partisan awareness on political issues; to provide educational information to Hispanic-American voters; to help them share equally in the responsibilities and regards of full citizenship.

ARTICLE IV MANNER OF ELECTIONS

The affairs of this corporation shall be managed by a Board of Directors elected by the members of the corporation as provided in the by-laws, provided, however, that all members of the Board of Directors must also be members of the corporation, and provided further, that no salaried personnel of the corporation shall be eligible to serve on the Board of Directors.

The Board of Directors shall consist of a Chairman, Vice-Chairman, Secretary, Treasurer, 1 Directors at large, and 2 from each chapter. The election to the Board and the manner of filling vacancies in the offices of the corporation shall be provided in the by-laws of the corporation.

The Board of Directors shall determine via the by-laws which executive officers will conduct the day-to-day operations of the corporation.

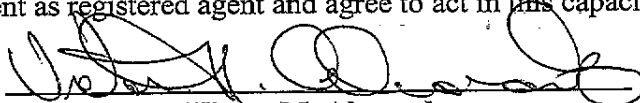
