ARTICLES OF INCORPORATION

of

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST:

Amendment adopted: The following provision of the Articles of Incorporation of POLISH CONGRESS HOUSING FOUNDATION, OF WEST CENTRAL FLORIDA, INC., a Florida corporation, filed in Tallahassee on October 10, 2002, be and they hereby are amended in the following particulars:
