To whom it may concern,

I received the document requesting a list of Trustees and Directors, and call to get further explanation of the documents. I mailed the document back, and it was sent back again for corrections. The necessary requested changes were mailed, and it was assumable taken care of. However, I didn't make a copy of it before I mailed it out, but it occurred sometime around the later part of July toward August. Since that time, we were given two hours notice to move out with all of our things from the building, because of some electrical and sewer violation. The City of Jacksonville ordered the whole entire apartment complex out within two hours, and no one could return back to that property, to even get their mail. A fence was placed around the property that prevented everyone from even getting their mail. On November 17, I went to the Post office, to find out about the mail, and picked up any mail that was on hold, and changed the address. Subsequently, I received in the mail a notice indicating that my incorporation was revoked or dissolved. Therefore I am resubmitting the application and requesting that the necessary fees be wavered in light of the circumstances.
