ARTICLES OF INCORPORATION
OF

SOUTHWEST FLORIDA CELEBRATION 2003, INC.

A Not For Profit Corporation

The undersigned subscribers to these Articles of Incorporation, being natural persons, competent to contract, hereby desire to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is SOUTHWEST FLORIDA CELEBRATION 2003, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of this corporation is 223 West Oak Street, Arcadia, Florida 34266, and the mailing address of the corporation is 223 West Oak Street, Arcadia, Florida 34266.

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is to work toward the enrichment and improvement of the Christian life of the citizens of Southwest Florida. To this end, the corporation shall have as its objectives:

1. The invitation and promotion for Southwest Florida area of an Evangelist and a Team from the Billy Graham Evangelistic Association for a united evangelistic celebration to be conducted February 20, 2003, through February 23, 2003.

2. To conduct activities and events during the period stated in 1 as above, which will be open to the public without admission charge.

3. To solicit funds from individuals, businesses, and corporations, and to receive offerings from people attending the services during the celebration to meet the anticipated expenses necessary to care for the financial needs of this Southwest Florida Celebration.

4. To receive and disburse the funds collected for the expenses incurred for items such as publicity, auditorium and stadium rentals, Celebration materials, administrative assistant salaries, office rental, stationery, postage, telephone expenses, other operational expenses, evangelistic Team salaries, living expenses, and transportation essential to the success of the Celebration.

5. To have a complete audit of the Celebration receipts and disbursements made by public accountants at the conclusion of the Celebration, and to make this audit a part of the public records of the Celebration.

6. To donate to Billy Graham Evangelistic Association any remaining balance of funds after all expenses are paid. To engage in no other activity than the promotion, conduct, and completion of the evangelistic celebration of February 20 through February 23, 2003, and to see to it that persons serving on various committees of the Celebration to so on a free and voluntary basis without financial compensation for their efforts in the promotion or conduct of the Celebration, and to operate the Celebration solely and exclusively on a benevolent basis.

7. The Celebration seeks to reach our community with the message that Jesus Christ came to seek and to save the lost and to give an opportunity for personal commitment to Him as Savior and Lord of their lives.

ARTICLE IV - MANNER OF ELECTION

The manner in which the directors are to be elected shall be stated in the bylaws.

ARTICLE V - ADDRESS

The street address of the initial registered office of the corporation is 223 West Oak Street, Arcadia, Florida 34266. The name of the corporation's initial registered agent at this address is TED W. LAND, who has signed these Articles of Incorporation. A statement accepting the appointment pursuant to Section 617.0501 is filed herewith.

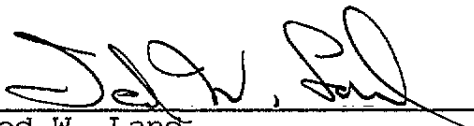
CERTIFICATE OF DESIGNATION OF
