A Florida Non profit Incorporation

The Undersigned, majorities of whom are citizen of the United States, desiring to form a Non-Profit Public Benefit Corporation under the Non-Profit Corporation Public Benefit Law of the State of Florida, do hereby certify:

ARTICLE I - Name of the Corporation INASMUCH ASSISTANT LIVING FACILITY, INC.

ARTICLE II - Location of Principal Office.

The place in this state where the principal office of the Incorporation shall be located 1007 West Wright Street Pensacola, FL 32501

ARTICLE III - Purpose


