KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, for the purpose of forming a corporation under the Corporation Code of the State of Florida, also known as the General Non-Profit Corporation Law, do certify the following:

ARTICLE 1

NAME

The name of the corporation shall be BOCA CENTRAL KOREAN BAPTIST CHURCH, INC.

ARTICLE 2

PURPOSES

This corporation is formed and shall be operated exclusively for charitable, religious, and educational purposes.

ARTICLE 3

DURATION

The term of existence of the Corporation is perpetual unless dissolved according to law.

ARTICLE 4

GAINS AND PROFITS

This corporation does not contemplate the distribution of gains, profits or dividends to the members thereof, and that no part of the earnings of the corporation shall inure to the benefit of any members, trustee, officer or individual.

ARTICLE 5

PRINCIPLE OFFICE

The principal office for the transaction of the business of the corporation is located at 289 E. Palmetto Park Rd, Boca Raton, Broward County, Florida 33432.

ARTICLE 6
