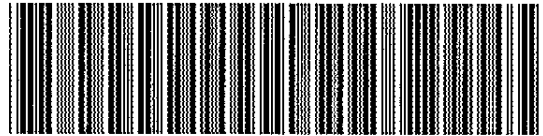

FIFTH: The adoption of dissolution was authorized by a majority of the directors.



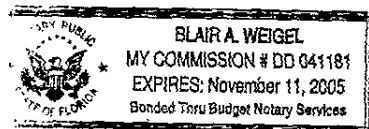
