

ARTICLE I Name

The name of the Corporation shall be: PIG ON THE POND, INC.

ARTICLE II

Duration

The existence of the Florida not for profit corporation shall be perpetual, commencing October 11, 2002, pursuant to Florida Statue 608.409.

ARTICLE III Principal Office

The street address of the initial principal office of the Corporation shall be: 1105 Bowman Street, Clermont, FL 34711.

ARTICLE IV Purposes

The Corporation is organized exclusively for charitable, educational and scientific purposes within the meaning of the Section 501 (c) (3) of the Internal Revenue Code, as amended, or any subsequent Internal Revenue Law (the "Code") limited to the following:

- 1. To support and promote charitable, educational and scientific organizations and purposes within South Lake County, Florida.
- 2. To receive by way of gift, purchase, grant, devise, will or otherwise, property (whether real, personal or mixed), and to hold, use, maintain, lease, grant, donate, pledge, encumber, loan, sell, convey and otherwise dispose of all such property in furtherance of the Corporation's objectives and purposes; and
- 3. To operate in connection with and exclusively for the benefit of and to carry our some or all of the purposes of South Lake County Community Foundation, Inc. ("SLCCF"), which is a Florida not for profit corporation which is exempt from federal income taxation under Section 501 (c) (3) of

the Code, which promotes, supports or furthers the purpose of charitable organizations with South Lake County and which are described in Section 509 (a) (1) and 509 (a) (2) of the Code.

ARTICLE V Limitation on Corporate Powers

The Corporation shall have all powers granted by law to not for profit corporations subject to the following limitations and/or restrictions. All of the assets and the earnings of the Corporation shall be used exclusively for charitable, religious, scientific or educational purposes within the meaning of Section 501 (c)(3) of the Code, in the course of which operation:

- 1. No part of the net earning of the Corporation shall inure to the benefit of, or be distributable to, an individual, including the directors of the officers of the Corporation, except that the Corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for the herein.
- 2. No substantial part of the activities of the Corporations shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office except as authorized under the Code.
- 3. The Corporation shall not engage in any business which would disqualify it from being exempt from taxation under Section 501 (a) of the Code as any organization described in Section 501 (c)(3) of the Code.

ARTICLE VI Board of Directors

Control of the affairs of the Corporation shall be vested in the Board of Directors. The Board of Directors of the Corporation shall have such duties, serve such terms and be elected in such manner as provided for in the By-laws of the Corporation.

ARTICLE VII Initial Registered Office and Registered Agent

The initial registered office of the Corporation is located at 1380 Grand Highway, Suite 200, Clermont, FL 34711, and the initial registered agent at such office is Wade Boyette, whose acceptance of appointment as registered agent for the Corporation is set forth below.

ARTICLE VIII Distribution Upon Dissolution or Liquidation

In the event of the dissolution or liquidation of the Corporation and after payment of just debts and liabilities, all remaining assets shall be distributed to (i) SLCCF, or its successor, if then qualified as an organization exempt from tax pursuant to Section 501 (c) (3) of the Code; (ii) or if SLCCF is not then so qualified, then to such charitable, religious, scientific or educational organization or organizations which would then qualify as exempt from tax under Section 501 (c)(3) of the Code, as designated by a circuit court in Lake County, Florida. No director, officer of private individual shall be entitled to share in the dissolution of any Corporate assets upon dissolution of the Corporation.

ARTICLE IX Incorporator
