Three: The purpose of this corporation is to engage in a NON-PROFIT corporation to hold interest in a food service trailer for the purpose of providing food to volunteer workers.

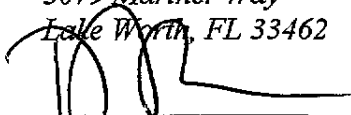

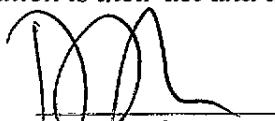
