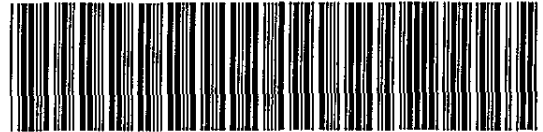

ARTICLE OF AMENDMENT
To

Pursuant to the provisions of section 617.1006, Florida statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its article of incorporation.

FIRST: The following amendments are to be made:

ARTICLE I NAME

The name of the corporation shall be: (In Spanish): **Iglesia Pentecostal Restauración Y Vida Inc.**
A Florida Not-for-Profit Corporation

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE(S)

We will serve as a missionary church and evangelistic body with a purpose of winning souls to Christ, with out distinction of ethnic or economical background. This ministry is based on the biblical apostolic doctrine and foundation. We will operate as a non-for-profit organization under the article for nonprofit in article 501.C, 3.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The President and the church will elect the initial board of directors. Upon the completion of the initial term, which is a one-year, future board members will be nominated by the president and church. Initial board of directors shall be elected as provided in the incorporation constitution and bylaw as from time to time in existence.

The president/director will retain his position as the senior pastor of the church. Change in the pastoral position will happen in the case of illness that will physically or mentally incapacitate him to fulfill the duties of this position, resignation, death or immoral act that will cause for his removal.

The number of directors constituting the initial Board of Directors of the Corporation is five, and the names and addresses of the persons who are to serve as directors of the Corporation until the first annual meeting of the members of the Corporation, or until one or more successors have been elected and qualify, are as follows:

ARTICLE VII MEMBER QUALIFICATIONS

ARTICLE VIII STOCK BASIS

The Corporation is organized under a non-stock basis.

ARTICLE IX NET EARNINGS

No part of the Corporation's net earnings shall inure to the benefit of or be distributable to its Members, Directors, or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III of these Articles of Incorporation.

ARTICLE X ASSETS

Upon the dissolution of the Corporation, the Corporation's assets shall be distributed only to another corporation that are subject to restraints substantially similar to those imposed on the Corporation by these Articles of Incorporation.
