AMENDING ARTICLE TWO - PURPOSE

The purpose for which the corporation is organized is the incorporation of a historical society not pursuing income from any business source, to operate exclusively for such social and community service purposes as will qualify it as a tax exempt organization under the Internal Revenue Code.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ADDING ARTICLE EIGHT - DISSOLUTION

In the event that the *Belleview/South Marion Historical Society, Inc.* should dissolve, the Board of Directors shall be empowered, after just debts and liabilities of this organization have been satisfied, to disburse all assets remaining to an educational or charitable purpose in line with the work already begun by this organization.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal Government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
