### ARTICLES OF INCORPORATION OF

#### CHILDREN AND FAMILIES DYASPO RELIEF FOUNDATION, INC.

The undersigned, acting as Incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I Name

The name of the Corporation shall be:
CHILDREN AND FAMILIES DYASPO RELIEF FOUNDATION, INC.

#### ARTICLE II Principal Place Of Business and Mailing Address

The principal place of business and mailing address of this corporation shall be: 8228 NE 2<sup>nd</sup> Avenue, Miami, Florida 33138

#### ARTICLE III Purposes

The purposes for which the Children and Families Dyaspo Relief Foundation, Inc. is organized are exclusively for charitable, religious, scientific, literacy and educational, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE IV Manner of Election of Directors

The manner in which the directors are elected or appointed shall be in accordance with the methods provided in the corporation By-Laws.

#### ARTICLE V Limitation of Corporate Powers

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay any reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to

an insubstantial degree, engage in any activities or exercises any powers that are not in furtherance of the purposes of this corporation.
