**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF

Pursuant to Section 617.1006 of the Florida Statutes, **FLORIDA SCHOOL FOR INTEGRATED ACADEMICS AND TECHNOLOGIES, INC.**, a Florida nonprofit corporation, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the nonprofit corporation is **FLORIDA SCHOOL FOR INTEGRATED ACADEMICS AND TECHNOLOGIES, INC.**
2. The nonprofit corporation was organized on October 21, 2002 by the filing Articles of Incorporation with the Florida Secretary of State.
3. Article I of the nonprofit corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:
