**ARTICLES OF INCORPORATION  
OF  
DIVINE LIGHT SPIRITUAL ZION CHURCH INC.  
A NON PROFIT CORPORATION**

I Anthony Bigmall , the undersigned natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a non profit corporation under the laws of the State of Florida. adopt the following Articles of Incorporation.

1. The name of the corporation is Divine Light Spiritual Zion Church Inc,
2. The corporation is a Non Profit ( religious, charitable, etc.) corporation.

3. The principal office

The principal place of worship shall be 2804 N.W 8 St , Fort Lauderdale Florida 33311 The mailing Address of the said corporation shall be 113 N State Road 7 )Plantation Florida 33317

4. purposes for which the corporation is organized are:

- a.To spread the Gospel of our Savior Jesus Christ and the Word of God, to the end that people of God may be conformed to the image of Jesus Christ.
- b.To bring both families of believers and individual believers in the lord Jesus Christ together in personal fellowship, worship, both in the home and in cell groups.
- c.To regularly assemble together the members of theChurch for fellowship one with another and to worship God in spirit and it truth ; and to cooperate in the assembling of the whole body of Christ.
- d. To provide basic Full Gospel discipleship to all members, and connect every member of this Church to the fellowship and activites of the Holy Spirit.
- e. To slove family and marital problems so that the home life of each person is healthy and fruitful

f. To baptize in water; to anoint the sick with oil to marry: to dedicate infants, to celebrate the Lord's supper and to bury..

d. The purpose for which Divine Light Spiritual Church Inc. is organized are exclusively religious, charitable, and/or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C) 3 of the Internal Revenue code, or corresponding section of any future federal tax code.

The corporation may receive and administer funds for scientific, religious, educational, and charitable purposes, within the meaning of section 501(c)3 of the Internal Revenue Code of 1986

e. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

f. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

4. The corporation shall have members which may be divided into such classes as shall be provided in the bylaws. All members shall be accepted, appointed, elected or designated in the manner provided in the bylaws.

5. The directors of the corporation shall be elected or appointed in the manner and for the terms provided in the Bylaws.

6. No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the corporation; and upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation,

**dispose of the residual assets of the corporation exclusively for the stated purposes of the corporation in such manner, or to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any future Internal Revenue Code. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, for such purposes or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.**

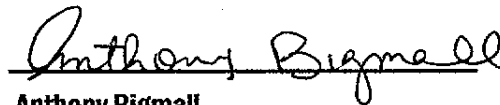

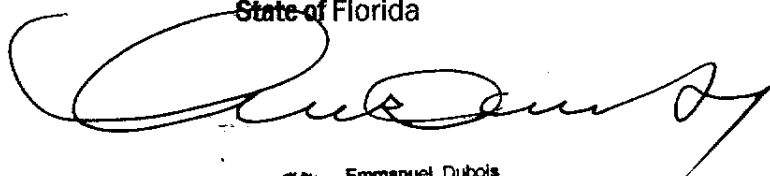
