**ARTICLES OF INCORPORATION
OF
Viewpoints Alliance Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **Viewpoints Alliance Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: The non profit corporation will be a self help organization designed to assist US citizens who are coping with high levels of stress and anxiety. The program will help participants to reframe negative thoughts and feelings as they participate in structured group meetings which will meet regularly. The organization will target 1. the general population including those suffering with anxiety disorders, 2. the public school systems (teachers, parents, and children), and 3. survivors of acts of terrorism, violent crimes, domestic abuse, or natural disasters.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
